Terms & Conditions

1. The Vendor (set forth above) certifies that all information submitted to the DANK Haus is valid and correct and the Vendor understands and agrees that the DANK Haus may rely on all such information when considering the selection of the Vendor as a Weihnachtsmarkt participant.
2. The Vendor understands that the DANK Haus may contact references, confirm information and investigate any information relating to the Vendor at the sole discretion of the DANK Haus in deciding whether or not the Vendor may participate in the Weihnachtsmarkt event.
3. The Vendor understands that a "per-table" fee is required to participate. The fee is one hundred and fifty dollars (\$150) for each table with an additional twenty-five dollar (\$25) electrical fee. Payment prior to October 31 will receive a discounted price of one hundred and twenty five dollars (\$125.) All payments shall be made in full, in U.S. currency and payable to the DANK Haus prior to the event.
4. The Vendor understands that all of its obligations to the DANK Haus end after the event has ended and the post-event clean-up has been completed. These Terms & Conditions shall expire on the day after the event.
5. The Vendor will sell products or goods that are of high quality and will ensure that its employees at the event conduct themselves in a professional manner. The Vendor will also come with enough product to sell for the time which Weihnachtsmarkt is open to the public.
6. The Vendor shall at all times comply with all applicable laws, ordinances, regulations and all lawful orders and guidelines of any duly constituted authority, and shall provide The DANK Haus with proof of a current license, permit or corporate registration in good standing as a business.
7. The parties' relationship is that of an independent contractor and nothing in these Terms & Conditions are intended to, or should be construed to create or imply a partnership, agency, joint venture or employment relationship. Each party represents and agrees that it is free to enter and perform pursuant to these Terms & Conditions, and it is not, and will not be under any restriction or prohibition, contractual or otherwise, which would prevent it from executing and fully performing this agreement and participating in the event. The DANK Haus shall be entitled to rely on the representations and warranties given by any person or persons named in the above application and in these Terms & Conditions.
8. Unless otherwise agreed, standard access to the location will be two hours before the event starts for set up, and up to two hours after the event has concluded to dismantle and remove all items brought to the event by the Vendor. If vendor needs additional set up time, they may set up the day before the event from 9:00 AM - 5:00 PM.
9. Vendor shall leave their rented area, and the table and chairs free from trash and in similar condition that it was in before the Vendor was there.
10. The parties agree that nothing contained in these Terms & Conditions shall be construed as creating an exclusive relationship between the parties.
11. Liability & Indemnity. Except as provided by Illinois law, the DANK Haus will not be liable to the Vendor for any damage to him/her/it or their guests arising from any act, omission or negligence and all claims for any such damages or injuries are hereby waived by the Vendor. The Vendor agrees to agree to indemnify, defend, and hold the DANK Haus, its directors, officers, employees and agents harmless of and from any liabilities, costs, penalties, or expenses arising out of and/or resulting from the rental and use of the premises or from participation in the event, including but not limited to, the personal guarantee of provision, service and dispensing of payment by the Vendor, its employees, and agents to any third-party that may have a claim against the Vendor in relation to the event.
12. Miscellaneous. These Terms & Conditions set forth the entire agreement between the parties, and may not be amended except in a writing signed by both parties. These Terms & Conditions will be governed by and construed in accordance with the laws of the State of Illinois, without regard to the principles of conflicts of law. The Vendor acknowledges that this arrangement and participation in the event is personal and unique in nature and the Vendor will not assign, transfer, sell or pledge any rights or obligations under these Terms & Conditions without the prior written consent of DANK Haus. Should any provision of these Terms & Conditions be held by a court of law to be invalid or unenforceable, such provision will be interpreted to accomplish the objectives of the provision to the greatest extent possible under applicable law, and the remaining provisions will continue in full force and effect.
